### **Authority of State Commissions to Regulate Rates of Public ...**

The Public Service Commission has jurisdiction over public power utilities' rate structure Louisiana Constitution: Article IV, § 21 The commission shall have no power to regulate any utility owned, operated, or regulated by the governing authority of one or more political subdivisions, except if approved by a majority of voters

### **Federal and State Quarantine and Isolation Authority**

Federal quarantine and isolation authority derives from the Commerce Clause of the US Constitution, which states that Congress shall have the power "[t]o regulate Commerce with foreign Nations, and among the several states"5 Section 361 of the Public Health Service Act
